AMENDMENT No. 6 TO RESELLER AGREEMENT FOR ORACLE PRODUCTS AND SERVICES

- 1. <u>Attachment 1, Article 3: Oracle Education Services and Learning Credits.</u> The Agreement is hereby amended under "22. Article 3." to delete this Section in its entirety as the new purchasing model for Oracle University is out of scope of the Agreement.
- 2. <u>Definitions.</u> All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
- 3. <u>Successors and Assigns.</u> This Amendment No. 6 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
- 4. <u>Entire Agreement.</u> Except as expressly modified by this Amendment No. 6, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. This Amendment No. 6 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
