GTA-Specific Bills

SB 53 (Sen. Hufstetler) – power to establish standards for state agencies' website design, navigation, and accessibility

HB 156 (Rep. Parsons) – mandatory cyber incident reporting

HB 159 (Rep. Parsons) – codify Cybersecurity Review Board

HB 388 (Rep. Mainor) – Atlanta Technology and Energy Enhancement Authority Act

HB 497 (Rep. Efstration) – code revision

HB 616 (Rep. Barr) – study potential statewide unique ID system and centralized business website

Proposed Policy Vote and Adoption

- Policy Vulnerability Disclosure Program Policy PS-21-001
 - Issue Date TBD

Establishes Vulnerability Disclosure Program (VDP) for the Executive Branch

- VDP aims to securely accept, triage, and rapidly remediate vulnerabilities submitted by the security research community.
- The policy defines the program elements:
 - *1. Promise*: A clear, good faith commitment to customers and entities potentially impacted by security vulnerabilities
 - *2. Scope*: Tools, assets, and vulnerability types covered
 - *3. "Safe Harbor"*: Assure that the finder reporting in good faith will not be unduly penalized
 - 4. *Process*: Used by finders to report vulnerabilities
 - *5. Preferences*: A living document that sets expectations for preferences and priorities regarding how reports will be evaluated



Vulnerability Disclosure Program

Overview

The Vulnerability Disclosure Program (VDP) aims to securely accept, triage, and rapidly remediate vulnerabilities submitted by our security research community.

Program participants:

- Office of Information Security
- Georgia Cyber Center and Augusta University
- Other State Agencies
- Local and Commercial Partners as required

A VDP is the digital equivalent of "see something, say something." It's intended to give clear guidelines for reporting potentially unknown or harmful security vulnerabilities to the proper person or team responsible.




