

**AMENDMENT No. 10 TO  
Reseller Agreement for Oracle Products and Services

This Amendment No. 10 is made this 24<sup>th</sup> day of June, 2020, by and between the **GEORGIA TECHNOLOGY AUTHORITY ("GTA")** and **MYTHICS, INC., (hereinafter referred to as "Reseller")**.

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Global Price List The Agreement is hereby amended and the attached Price Breakdown Worksheet including Mythics Consulting Rates, is added to the Global Price List.
2. Article 3, Oracle University Terms and Conditions: The Agreement is hereby amended under "24. Article 3" to delete this Section in its entirety and replace with the following:

This Amendment No. 10 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
