

**AMENDMENT No. 11 TO
RESELLER AGREEMENT FOR ORACLE PRODUCTS AND SERVICES
CONTRACT NUMBER 9800-RFP-000000112-62015MYT**

This Amendment No. 11 is made this 29th day of June, 2021, by and between the **GEORGIA TECHNOLOGY AUTHORITY** ("GTA") and **MYTHICS, INC** ("Reseller").

WHEREAS, heretofore GTA entered into that certain Agreement for Services effective on June 30, 2015, which shall now include Agreement for Services effective on July 1, 2019, with respect to certain services to be provided to GTA by Reseller, as more particularly described therein as amended by the following amendment (collectively, the Reseller Agreement for Oracle Products and Services and all the Amendments hereinafter referred to as the "Agreement"):

WHEREAS, the parties wish to amend the Agreement to reflect certain changes.

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Term and Renewal. The Agreement is hereby amended by extending the term from July 1, 2021 until July 31, 2021.
2. Definitions. All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
3. Successors and Assigns. This Amendment No. 11 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
4. Entire Agreement. Except as expressly modified by this Amendment No. 11, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. This Amendment No. 11 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
