

**AMENDMENT No. 14 TO  
GEORGIA TECHNOLOGY AUTHORITY  
RESELLER AGREEMENT FOR ORACLE PRODUCTS AND SERVICES  
CONTRACT NUMBER 9800-RFP-000000112-62015MYT**

This Amendment No. 14 is made this 22 day of February 2022, by and between the **GEORGIA TECHNOLOGY AUTHORITY** ("GTA") and **MYTHICS, INC** ("Reseller").

WHEREAS, heretofore GTA and Reseller entered into that certain Reseller Agreement for Oracle Products and Services on June 30, 2015 (the "Reseller Agreement"), with respect to certain services to be provided to GTA by Reseller, as more particularly described therein.

Amendment No. 11 entered into on June 29, 2021;  
Amendment No. 12 entered into on July 8, 2021; and  
Amendment No. 13 entered into on July 19, 2021.

WHEREAS, the parties wish to amend the Reseller Agreement, as amended, to make those certain changes set forth herein (as amended, the "Agreement").

NOW, THEREFORE, in consideration of the premises, the terms and conditions stated herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Global Price List. The Price Breakdown Worksheet, as set forth in Amendment No. 10, is hereby replaced by the attached Price Breakdown Worksheet.
2. Definitions. All capitalized terms used herein and not expressly defined herein shall have the respective meanings given to such terms in the Agreement.
3. Successors and Assigns. This Amendment No. 14 shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.

4. Entire Agreement. Except as expressly modified by this Amendment No. 14, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations of the parties. In the event of any inconsistencies between the Reseller Agreement, as amended, and this Amendment No. 14, the terms of this Amendment No. 14 shall control. This Amendment No. 14 and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
